**QUARTER 4, 2017 TREASURY BOND (INSCRIBED STOCK) ISSUANCE PLAN**

Consistent with our advice on the Government's annual debt strategy and issuance plan for 2017 issued on 24 January 2017, we now announce the Inscribed Stock Issuance for Quarter 4, 2017. We are now issuing K24.50 million for October and K70.00 million for November whilst December will depend on the appropriation remaining balance after the outcome of the tender results for October and November. The details for each month issuance are listed below.
